# Preface

This is the first edition of IAPMO Z1349, Devices for Detection, Monitoring or Control of Plumbing Systems. This Standard supersedes IAPMO IGC 115-2013<sup>e1</sup>, *Automatic Water Leak Detection Devices* and IAPMO IGC 349-2018<sup>e1</sup>, *Electronic Plumbing Supply System Integrity Protection Devices*.

This Standard is considered suitable for use for conformity assessment within the stated scope of the Standard.

This Standard was developed by the IAPMO Z1349 Technical Subcommittee and approved by the IAPMO Plumbing Standards Committee in accordance with the *ANSI Essential Requirements: Due process requirements for American National Standards, IAPMO Policies and Procedures for Consensus Development of American National Standards, SCC Requirements and Guidance - Accreditation of Standards Development Organizations*, and *IAPMO Policies and Procedures for Development of National Standards of Canada*. This Standard was approved as an American National Standard on January 15, 2021 and as a National Standard of Canada on February 16, 2021 it will be reviewed before February 16, 2025.

## Notes:

- (1) *The use of the singular does not exclude the plural (and vice versa) when the sense allows.*
- (2) *This standard was developed in accordance with the IAPMO procedures accredited as meeting the criteria for American National Standards and as a National Standard of Canada.
